Elected in November of 2016 to represent California’s 3rd Senate District, Senator Bill Dodd is a fifth generation Californian and lifelong resident of the district, where he grew up on a small family farm in Napa County. California’s 3rd State Senate District includes all of Napa and Solano Counties, along with portions of Sonoma, Yolo, Contra Costa, and Sacramento Counties. Prior to his election to the State Senate, Bill represented the 4th Assembly District. In the Assembly, he worked to help small businesses, protect the environment, and support seniors and working families. Prior to his election to the Assembly, Senator Dodd served on the Napa County Board of Supervisors for 14 years.

Bill was a successful small business owner and manager for over 25 years prior to his public service. He owned and operated one of the largest full-service Culligan Water operations in California, and served as president of the water quality industry’s state and national trade associations. Senator Dodd is a graduate of California State University, Chico. Bill and his wife Mary live in Napa and have five grown children and six grandchildren.
